## 1 Update of 2014-15 Quarter 3

This quarter had a greater focus on academics, guiding the PUC 1<sup>st</sup> year students in their studies, conducting preparatory exams for 2<sup>nd</sup> PUC students towards getting them ready to face the board exams. Exposing the 2<sup>nd</sup> degree students to job interviews and preparing the final year degree students to face job interviews.

## 1.1 Overview on Academic Sessions

The Sunday sessions continued as usual with the regular English and doubt clearing for other subjects. The final B.Com students had special sessions on Taxation and Advanced Financial Accounting. Aptitude sessions continued with the degree students along with group discussion sessions.

Preparatory exams were conducted for the  $2^{nd}$  PU students to assess their preparedness for the coming board exam. The weaknesses of the students have been identified and we are working towards strengthening them.

## 1.2 Entering into professional world - Session for Passed out students

Over the years it has been noticed that some of our graduate students were finding it difficult to adjust into the professional environment and at times were even getting demotivated. They were unable to manage the expectations and pressures of the corporate world as well as their family.

A session was conducted for the passed out students of 2014 to help them handle and manage these expectation and pressures. A brief write up (Section6.1) on the sessions is available in Students area written by Pooja (2014 graduate).

### 1.3 Session on CV preparation

A session on drafting resume was conducted for the students pursuing 2nd year degree and above on 12th October 2014 by Rohit, our Mysore based volunteer. The session, which was attended by approximately 20 students covered basics including the significance of a good resume, differences between the terms Biodata, Curriculum Vitae and Resume, major sections of a resume and ways of presenting academic and extra-curricular achievements succinctly, yet effectively. The students were also given hands-on exercises to draft and evaluate each other's resumes. At the end of the session, it was felt that more practice time is needed and follow-up sessions on the topic would be planned shortly.

#### 1.4 Joys

Students settling in their life gives us the biggest pleasure. It was joyous moment to see Gayathri and Sowmya, two of our 3<sup>rd</sup> B.Com students getting offers through campus placements. Gayathri has got offers from Ven India Pvt Ltd and ICICI, whereas Sowmya got an offer from ICICI. It is a good start to the placements season, we have another 6 students to be placed this academic year.

It is also energizing and motivating to see some of our 2014 batch pass outs coming back as volunteers and taking up responsibilities and providing us a big helping hand.

#### 1.5 Christmas and Diwali Celebrations

Volunteers visit various children's homes for Diwali and Christmas Celebrations with the students in these homes. This Diwali, the volunteers visited Kutumba, a home for physically challenged children in Kothanur. We distributed sweets and burst crackers with the children.

Christmas eve is the time to sing Carols, this year about 5 volunteers and 10 students visited Vatsalya, a home for girls from economically disadvantaged families. The volunteers sang carols and distributed cakes and gifts to the girls.

The costs for the celebrations were borne by the volunteers and were not drawn from the FoCH funds.

#### 2 Financial Statement of Q3 2014-15

This quarter we have spent Rs. 59,589 of which 60% was spent towards fees, 18% was spent towards lunch for students on Sundays, 10% towards medical expense, 7% towards Stationery and Books, remaining 5% on other miscellineous expenses.

We have received donations to the tune of Rs. 89,500 and our balance at the end of the quarter is Rs. 2, 16,268.




Figure 1: Expense Breakup

The breakup of total expenses is graphically illustrated in Figure 1
